## From the District Superintendent

Dear Staff,

There were three phone messages one day last week. The first was from a colleague talking about the mid-year budget cuts; the second was from the Post-Standard asking for comments on the Comptroller's audit of our BOCES; and the third was from a parent. In many ways, these three messages are symbolic of my message for you this month.

**Budget.** There is no doubt in my mind that New York State's fiscal health is bleak and will have an impact on all of us, professionally as well as personally. I heard the Lt. Governor speak to the Board of Regents last week and he projected the state's deficit at \$3-4 billion for the fiscal year ending in March, an additional \$5 billion for the next fiscal year, and an **additional \$15 billion** in 2012. This will have significant impacts on the way schools and BOCES operate. The projected mid-year budget cuts to schools in our area are in excess of \$20 million dollars. The silver lining, if there is any, may be that our districts will turn to us to develop new cooperative cost-effective services.

**Audit.** The headline in the Syracuse paper about our audit sensationalized the actual content of the audit. This letter does not provide the space for me to truly explain what the audit said and what the reality of our financial practices are. Included toward the end of the audit is our BOCES response to the draft report. The letter, available on the Board to Board Newsletter page of the OCM BOCES website, explains our practices in more detail.

**Parent message.** Let me end this letter with the message that made me smile. A parent, who I didn't know, called and left a message that made me smile. She had been at an open house for our CTE programs and wanted me to know that "for the first time in his life, my son loves coming to school. He loves his teacher,

he loves his program, and he loves BOCES! BOCES has turned our lives around." That is a message that I hear repeated from parents and students.

In the midst of the doom and gloom in the news, there is so much to be thankful for. I am thankful for our wonderful staff and the great work they do everyday. Have a happy Thanksgiving!
